In October 2019, a revision to the Massage Program curriculum was approved and the name changed to Therapeutic Massage.

In October, 2019, a revision to the Medical Office Administration with Billing and Electronic Registration program and name change to Medical Billing with Office Administration was approved.

In August, 2020, the initial authorization to offer all study programs through the hybrid modality is received from our Accredint Agency, ABHES. The Residential modality is also maintained.

In February 2022, the Medical Billing Program with Office Administration was eliminated from the ACH's academic offer.

PHYSICAL ADDRESS VALIDATION POLICY, Page 22

The academic offer under the hybrid modality (blended) of Antilles College of Health is authorized to be offered only in Puerto Rico. The Institution will require from the applicant evidence of physical location to verify that their residence is in Puerto Rico. If in effect, it is validated that you reside outside of Puerto Rico, you will be notified that to enroll in Antilles College of Health you must be a resident of Puerto Rico.

The Institution will notify that relocating to other states and / or countries will affect the educational process of the student, since the study programs require the participation of the student in person to carry out laboratories, internships and / or clinical practices (in the programs that apply, therefore, the student will not be able to continue their studies at ACH.
